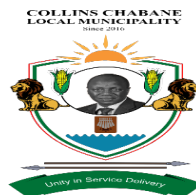

Notice is hereby given in terms of Section 49(1)(a)(i) read together with Section 78(2) of the Local Government: Municipal Property Rates Act, 2004 (Act No.6 of 2004), hereinafter referred to as the "Act", that Collins Chabane local municipality supplementary valuation roll for the financial year 2024/25 is open for public inspection at municipal offices from the 2<sup>nd</sup> December 2024 to 31<sup>st</sup> January 2025 at Malamulele Civic Centre, Malamulele DCO building, Vuwani sub-office and Njhakanjhaka community hall. An invitation is hereby made in terms of Section 49(1)(a)(i) read with Section 78(2) of the Act that any owner of property or other person who so desires, may lodge an objection with the Municipal Manager in respect of any matter reflected in, or omitted from the supplementary valuation roll within the above mentioned period.

Attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the supplementary valuation roll as such. The form for the lodging of an objection is obtainable at Malamulele Civic centre, Property Management, Housing and Building control office and Vuwani sub-office.
