The Objector's attention is specifically drawn to the fact that in terms of Section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation as such.

If no information regarding the valuation of the properties is received by mail, every person must enquire at the Municipal Offices for said information.
